  <u>Programme</u> by the Organizers if and when the <u>Registration Fee</u> has been paid by the respective participants
- (e) hand out The <u>Conference Map</u> with the printed Final Programme and Name Tag to the participants only against payment of the <u>CIEPO Membership Fee</u> of Euro 10,-, US\$ 15 or 30 Turkish Lira per member and venue (the CIEPO Membership Fee <u>receipt</u> serves the additional purpose of <u>Voting Card</u> in the General Assembly members be <u>made aware</u> of this function by the Organizers)

- (f) the principle that eventual participation would be decided by a <u>double-blind Vetting Board</u> on the basis of the (anonymized) Abstracts;
- (g) the fact that the <u>Vetting Board</u> consists of members of the CIEPO Executive Board and Governing Directorate whose names are withheld;
- (h) give <u>preference</u> to <u>Workshops and Panels</u> over individual presentations
- (1) give <u>preference</u> to <u>Internationally Staffed Workshops and Panels</u> (with contributors from more than one country) over workshops and panels in general
- (i) to organize the 22<sup>nd</sup> CIEPO between <u>Tuesday 4 October</u> and <u>Saturday 8 October 2016</u>
- (k) the venue (including Opening Ceremony and General Assembly as well as <u>Excursion</u>) lasts no more than 6 days
